



Juvenile Justice Crime Prevention Act - Youthful Offender Block Grant

These code sections both call for a consolidated report format that includes a description of the programs and other activities supported by JJCPA and/or YOBG funds, an accounting of all JJCPA and YOBG expenditures during the prior fiscal year, and countywide juvenile justice trend data.

Prior to submitting this report save the file using the following naming convention: "**(County Name) 2019 JJCPA-YOBG Report.**" For example, Yuba County would name its file "Yuba 2019 JJCPA-YOBG Report".

Provide a summary description or analysis, based on available information, of how the programs, placements, services, strategies or system enhancements funded by JJCPA-YOBG have, or may have, contributed to, or influenced, the juvenile justice data trends identified in this report.

The focus of the Amador County Probation Department is primarily prevention driven. Identifying juveniles at risk and collaborating with our community based agencies has allowed the juvenile probation officer to access programs which focus acutely on the needs of the minor and their family. Referring minors and their families to programs such as Nexus Agression Replacement Therapy and 180 Degree U-Turn have proven to help enhance informal interaction with the Probation Department and law enforcement when engaging youth who are at risk within our community. The 2018 year was abnormal in that referrals to the Probation Department were much lower as well as Court intervention. Additionally, more creative dispositions prior to court involvement have been implemented prior to or at intake with the Probation Department. The Probation Department has a strong relationship with the school district as well and is very active with truancy prevention and referring families in need for services.

JJCPA funds were utilized to pay for the salaries and benefits of one juvenile probation officer. The juvenile probation officer is assigned to collaborate with Amador County Schools, community based organizations, and Amador County Health and Human Services. The juvenile probation officer addresses school truancy and disciplinary issues within Amador County's seven elementary schools, three junior high schools, two high schools, and three alternative schools. The juvenile probation officer collaborates with a community based organization, Nexus Youth and Family Services, which offers anger management program, substance and abuse counseling, and counseling preventative services. In addition, the juvenile probation officer is involved in a multidisciplinary team which involves Amador County Health and Human Services to identify youth that may need additional services.

The mental health clinicians and the juvenile probation officers collaborate to address transportation, access, and financial barriers to ensure the youth receive appropriate mental health treatment.

Amador County Probation contracts and refers youth to a community based organization, Nexus Youth and Family Services, for the Aggression Replacement Therapy (ART) groups. The juvenile probation officer collaborates with local schools, Amador County Health and Human Services, and parents to assess youth for the ART program. ART groups assist in reducing negative behaviors, disciplinary action in the school setting, time on probation, and recidivism in the Juvenile Justice System. ART is a multi-modal intervention designed to alter the behavior of chronically aggressive youth. It consists of three components: skill streaming which is designed to teach a broad curriculum of pro-social conduct, anger control which is a method for empowering youth to modify their own anger responsiveness, and moral reasoning training which is to help motivate youth to employ the skills learned via the other components. The goals and expected benefits are to promote skill acquisition and performance, improve anger control, decrease the frequency of acting out behaviors, and increase the frequency of pro-social constructive behaviors.

During this reporting period, 19 students participated in ART services. The youth addressed topics of identifying and understanding emotions, goal-setting, positive decision-making, under age vaping-myths and realities, marijuana and other drugs, stress management, knowing your feelings, and anger and behavior triggers to name just a few.

Amador County contracts and refers youth between the ages of 9 through 18 years of age identified as being high risk to Nexus Youth and Family Services for the 180 Degree You-Turn Program. The program offers four groups throughout the school year. The program encompasses group discussions, conflict resolution, education, leadership, community service, diversity, personal values, integrity and future goals. The Nexus Youth and Family Services' staff organized field trips designed to expose the program participants to a variety of experiences and opportunities which they were actively and cognitively engaged and challenged. During this reporting period, 32 youth participated in the 180 Degree You-Turn Program which included groups and individual mentoring support. The youth participated in excursions or field trips in career, vocational, volunteer, and scholastic settings; such as, Volcanic Adventure Camp at Lassen National Park, Plymouth Nature Walk, Upcountry Community Center Service Project, Department of Motor Vehicles, Kennedy Mine and Peer Leadership in Jackson.

Amador County Probation contracts with AutoMon, LLC to maintain the case management and reporting systems through the vendor's annual maintenance and escrow fees. The case management and reporting systems allow the juvenile probation officer to track all aspects of the juvenile caseload. In addition, the Juvenile Assessment Intervention System (JAIS) is embedded in the case management system which is a juvenile assessment tool. The JAIS component classifies the youth as low, medium, or high risks. The assessment also identifies their needs to successfully complete probation and reduce recidivism; such as, mental health or substance abuse referrals, ART or 180 Degree You-Turn Program referral, and family counseling.
