



Juvenile Justice Crime Prevention Act - Youthful Offender Block Grant

These code sections both call for a consolidated report format that includes a description of the programs and other activities supported by JJCPA and/or YOBG funds, an accounting of all JJCPA and YOBG expenditures during the prior fiscal year, and countywide juvenile justice trend data.

Prior to submitting this report save the file using the following naming convention: "**(County Name) 2019 JJCPA-YOBG Report.**" For example, Yuba County would name its file "Yuba 2019 JJCPA-YOBG Report".

Provide a summary description or analysis, based on available information, of how the programs, placements, services, strategies or system enhancements funded by JJCPA-YOBG have, or may have, contributed to, or influenced, the juvenile justice data trends identified in this report.

Comparing arrest data from 2017 to 2018, there has been a 32% decrease in total juvenile arrests (342 arrests in 2017 to 233 in 2018). This downward trend may have been influenced by the effectiveness of juvenile programs funded (in whole or in part) by JJCPA and YOBG grants. For example, the Community Alliance to Reduce Truancy (CART) program (funded by JJCPA) represents collaboration between the El Dorado Probation Department, county schools and the community. The CART program works with juvenile offenders to assist improving school attendance, school behavior, and academic performance. CART officers also identify appropriate services for youth and their families, not only youth on probation, but also extending to “at-risk” youth who are not under probation supervision. This collaboration between the department and community displays efforts to establish a continuum of care for youth throughout El Dorado County. This focus on intervention and prevention may have contributed to influencing the downward trends in youth entering the juvenile justice system.

In addition to the trends identified above, we have also noticed downward population trends in our detention centers. Specifically, at our Juvenile Treatment Center (JTC), funded by YOBG, we have seen a 45% decrease in number of bookings, from 77 in 2017, to 42 in 2018. Based on research that shows detention increases the likelihood of a youth returning to the justice system, El Dorado County has made significant changes to reduce the number of youth detained while increasing the number of youth diverted through informal interventions. Other influences for the decrease in number of bookings could include the CART program discussed above, in addition to the care youth receive at our juvenile detention facility. The population detained receives education, recreation, counseling and other intervention services specialized to the youth in order to maximize well-being while in detention. Staff in our detention facilities have also received training focused on trauma informed care to better identify and provide appropriate services to youth to help them achieve positive outcomes. The decreases in youth detained are significant, as it represents more resources available in order to provide services and programs to the youth that are incarcerated in each facility.

Historically, probation officers were assigned to local high schools that have been identified as having the majority of "at-risk" youth and students who are receiving probation interventions. Due to declining populations of delinquent youth, in FY 15/16 modifications were made to the CART program to expand program to all students in a seat based school program, regardless of the school each attends.

The interventions and services of the probation officers assigned to youth who attend local high schools have continued to assist youthful offenders with improving school attendance, school behavior, and academic performance. Additionally, officers assist youth with quality of life outcomes, such as engagement in pro-social activities, ensuring youth have necessities such as transportation to school, and providing incentives for completing intervention goals and improving behavior. Each officer identifies appropriate services for each youth, and his/her family, based on risk and needs assessments and the resulting case plan which outlines interventions based on criminogenic needs. Further, officers hold youthful offenders accountable to their conditions of probation, and continually strive to deter future delinquent activity. The CART program also continues to assist in establishing and maintaining collaborative alliances with the school and community, and strives to assist in referring families and "at-risk" youth who are not under probation supervision to appropriate interventions and services, thus providing safer schools and neighborhoods throughout El Dorado County.

YOYG funds are used to pay for staffing, including all training activities for staff that provide routine and standard housing and treatment of youthful offenders, at the Juvenile Treatment Center (JTC) in South Lake Tahoe. Staffing consists of twenty full-time institutional probation officers and one licensed mental health program coordinator, who provide supervision and interventions in a facility with an overall capacity of forty beds. Due to budget constraints, we have limited the population cap to thirty beds as of July 1, 2009. Youth are detained based on risk and needs assessments, including a detention risk assessment, as well as objective decision-making. Institutional probation officers are all CORE trained and provide education, recreation, health, assessment, counseling and other intervention services to maintain a youth's well-being during incarceration.

The El Dorado County Probation Department currently contracts with Madera County to place youthful offenders in the Juvenile Youth Camp as established by Madera County, located at 28219 Avenue 14, Madera, CA 93638, and Humboldt County New Horizons program located at 2004 Harrison, Eureka, CA 95501. These programs offer ranch/camp services in these specific locations, offering structure, therapeutic intervention, accountability, education, and family involvement in the rehabilitation process in a correctional, in-custody setting. New Horizons also provides an intensive mental health treatment program.

No youth were placed in these programs in the 2018 fiscal year.
