



Juvenile Justice Crime Prevention Act - Youthful Offender Block Grant

On or before October 1, 2019, each county is required to submit to the Board of State & Community Corrections (BSCC) a report on its Juvenile Justice Crime Prevention Act (JJCPA) and Youthful Offender Block Grant (YOBG) programs during the preceding year. For JJCPA this requirement can be found at Government Code (GC) Section 30061(b)(4)(C) and for YOBG it can be found at Welfare & Institutions Code Section (WIC) 1961(c). These code sections both call for a consolidated report format that includes a description of the programs and other activities supported by JJCPA and/or YOBG funds, an accounting of all JJCPA and YOBG expenditures during the prior fiscal year, and countywide juvenile justice trend data.

Prior to submitting this report save the file using the following naming convention: "**(County Name) 2019 JJCPA-YOBG Report.**" For example, Yuba County would name its file "Yuba 2019 JJCPA-YOBG Report".

Provide a summary description or analysis, based on available information, of how the programs, placements, services, strategies or system enhancements funded by JJCPA-YOBG have, or may have, contributed to, or influenced, the juvenile justice data trends identified in this report.

It's very difficult to differentiate between data anomalies and trends when our overall numbers are so small. However, juvenile referral and intake data from this past year shows that this increase is not related to incidents involving multiple juveniles, but instead shows a general overall increase in juvenile crimes. Additionally, the 30% increase in ward placements also indicates that these other increases are not simply innocuous juvenile matters but rather more complicated juvenile cases that require significant resources to address. One of these cases even resulted in a DJJ commitment, of which we haven't seen here in Trinity County in nearly a full decade.

YOYG funds were used to provide staffing for and to conduct comprehensive assessments on new juvenile cases, provide case planning and intensive home supervision to our highest risk juvenile population, and assist in diverting youth away from higher levels of care and incarceration. The tool we are using for determination of juvenile risk is the PACT assessment, which screens for level of risk. Higher risk youth who are at the greatest risk of commitment to the State Division of Juvenile Justice (DJJ) are provided more intensive supervision and services by a seasoned Deputy Probation Officer, and all services and intervention strategies align with the Risk-Needs-Responsivity (RNR) model of evidence-based practice.

JJCPA funds were used to provide staffing for and to support on-going efforts related to our School-Based Prevention/Intervention Program. This program plays a key role in the school SMART team which assists in crisis response to ensure youth safety, and also provides general education, prevention, and intervention services to students through a variety of methods and incorporates a school-based restorative justice model to ensure that youth are not brought into the juvenile justice system unless legally necessary and all other options are not feasible or practical. This program is one of the primary reasons why Trinity County's juvenile incarceration and ward rates remain as low as they are. With limited other youth resources in our county for prevention and intervention services, proposed legislation that would curtail probation's ability to preform prevention and intervention services would severely negatively impact our youth and effectively remove what few services they do have.

The tool we are using for determination of juvenile risk is the PACT assessment, which screens for level of risk. Higher risk youth who are at the greatest risk of commitment to the State Division of Juvenile Justice (DJJ) are provided more intensive supervision and services by a seasoned Deputy Probation Officer, and all services and intervention strategies align with the Risk-Needs-Responsivity (RNR) model of evidence-based practice.

JJCPA funds were used to provide staffing for and to support on-going efforts related to our School-Based Prevention/Intervention Program. This program provides education, prevention, and intervention services to identified youth populations and certain at-risk youth and who have been referred to probation by the schools, through local law enforcement agencies, child protective services (CPS), parents and/or the Community. The program components include a variety of services and referrals related to parenting, substance abuse, mental health counseling, truancy intervention, and education-related events regarding consequences of our actions and behaviors.
