### Meeting Called to Order

### Agenda Item A

### Welcome, Updates, and Reminders

#### SACJJDP Updates

- BSCC Field Representative Timothy Polasik provided an update on the Community Input contracts reporting that all contracts have been executed and the contractors have begun work.
- Polasik reported that the recommendation to the board for approval for the R.E.D. contract with WestEd was approved at the April 8, 2021 BSCC Board meeting. The spending authority is pending approval of the California 2021-22 budget. The expectation is the contract will begin July 1, 2021.
- SACJJDP Member Kent Mendoza reported that the Anti-Recidivism Coalition (ARC) contract was underway. Mendoza stated that 4 listening sessions were already conducted, and 2 additional meeting were scheduled for the week of May 3, 2021 at the youth correctional facility in Ventura County. Mendoza added that ARC staff had

engaging directly impacted youth released from the California Department of Corrections and Rehabilitation, Division of Juvenile Justice facilities. Mendoza noted that the listening sessions are recorded. ARC is exploring the option to convert some of the content for training sessions to help people understand the youth by hearing from them directly. The idea is that the recordings would help others to understand the challenges at-risk youth confront daily.

**Discussion on the Title II 3-Year Plan**

- The committee discussed the draft 2021-2023 3-Year State Plan. Polasik provided a brief overview of each section of the draft stating. The committee reviewed the crime data section and highlighting that there will be significant updates to the section as WestEd completes the R.E.D. contract deliverables. The committee members agreed to review the draft 3-year plan and provide comments by May 14, 2021.
