Grant Activity

Prop 47

On June 8, 2017 the Board approved the ESC's award recommendations of approximately \$103 million to 23 grantees (15 large (one partial) and 8 small). The list of grantees with additional detail is posted on the BSCC website.

JAG

We have been informally advised that the JAG solicitation will be released in July. We anticipate bringing an RFP to the Board for approval in September and bringing award recommendations to the Board in February 2018. On June 8, 2017 the Board approved, subject to BJA approval, no cost, one-year extensions to current JAG grantees. If BJA approves, this will add calendar year 2018 to the current grant cycle for the 17 counties that have requested this.

RSAT

The 2017 solicitation was released on June 2 and we are preparing our application which is due on July 5. States are advised that the FY 2017 allocation amounts are unavailable and may not be available until a much later date. Once the FY 17 allocation amounts are available, states will be notified and will be required to revise applications accordingly. Current RSAT grantees will begin year 3 of a 3 year grant cycle on July 1.

Title II

Awaiting response to our FFY 17 submission and to be advised of award amount. We will be sending out the Request for Applications from Title II grantees over the summer – R.E.D. will be entering its 4th and final year and Title II and Tribal will be entering its 3rd year of a 4 year cycle.

Proud Parenting

On June 8, 2017 the Board approved the appointment of Board Member Chief Ertola to chair an ESC that will develop the Proud Parenting RFP, rate proposals and develop award recommendations for the next grant cycle that would begin on July 1, 2018 subject to an appropriation.

Legislative Reports

We are finalizing our annual Community Corrections Partnership annual Legislative Report and anticipate its release by July 1.

YOBG/JJCPA Plans

2017 YOBG/JJCPA plans (due annually each May) are posted on the BSCC website. We are currently developing instructions for counties on the annual October reporting.
